ORDER:

WHEREAS, pursuant to the letter of the Committee, the following representatives of the Tamil Nadu Private Professional Colleges Association-Health Sciences (hereinafter called as 'TNPPCA-HS' for brevity) and the representative of the All India Recognised Nursing Schools and Colleges Association, Karur (hereinafter called as 'Nursing Association' for brevity)

WHEREAS the Tamil Nadu Private Professional Colleges Association –Health Science requested the Committee to authorize the Association to carry out the process of selection and admission of students in respect of B.Sc.(Nursing) / B.Pharm/ B.O.T/B.P.T/Pharm. D courses in respect of their member institutions.

WHEREAS it is further stated by the Associations that their respective member-institutions **consensually agreed** to part with 65% of their respective available seats in the Allied Health courses of study in the case of non-minority institutions or 50% of those seats in the case of minority institutions, as the case may be, to the State Government to be filled up by it and the remaining 35% or 50%, as the case may be, is to be filled based on the merit list of the respective Associations.

WHEREAS the All India Recognised Nursing Schools and Colleges Association requested the Committee to authorize the Association to carry out the process of selection and admission of students in respect of B.Sc.(Nursing) course in respect of their member institutions.

WHEREAS, the Committee appraised the procedure to be followed in the selection and admission of students to the number of seats retained by the institutions in respect of B.Sc. Nursing/B.Pharm./B.O.T./B.P.T./ Pharm. D courses

for the academic year 2025-2026 by the TNPPCA-HS and B.Sc. Nursing course during 2025-2026 by the All India Recognised Nursing Schools and Colleges Association, having regard to the facts and considering the procedure followed by the Associations in the previous years, the Committee unanimously resolved to accept the request and authorize the TNPPCA-HS to carryout the process of selection and admission of the students in respect of B.Sc. Nursing/B.Pharm./B.O.T./ B.P.T./ Pharm. D courses, in respect of its respective member institutions, and the Nursing Association to carryout the process of admissions of the students in respect of B.Sc. Nursing course only to its member institutions by scrupulously adhering to the procedures prescribed hereunder, under the supervision of the Committee.

- Admission to the seats in B.Sc.Nursing /B.Pharm. / B.O.T./B.P.T/ Pharm. D courses available to the member institutions of the Associations shall be Regulated and Monitored strictly by the Committee as per the judgments of the Supreme Court in the cases of Islamic Academy v. State of Karnataka, (2003) 6 SCC 697 and P.A. Inamdar v. State of Maharashtra, (2005) 6 SCC 537.
- 2. In respect of the above courses, the TNPPCA-HS/Nursing Association, is required to follow the schedule below

The permission so accorded is attached with the following conditions:

- Application form: The application form for the courses shall be a common one and shall be issued by the TNPPCA-HS and Nursing Association. No individual institution shall issue applications in its name.
 - a) Application form shall correspond / similar to the application issued by the Government. The booklet containing the details about the various colleges, which are Members of the TNPPCA-HS / Nursing Association, namely, the courses offered, the tuition fees fixed by the committee, facilities available and other relevant details, shall accompany the application form, as done by the Government. The TNPPCA-HS / Nursing Association shall host the details in its official website.
 - b) The application fee shall be the same as fixed for the Government Colleges.
 - c) Application forms should be made available at the registered office of the TNPPCA-HS / Nursing Association and the office of the Committee at F1, DOTE Staff Quarters, Gandhimandapam Road, Guindy, Chennai 25.
 - d) The TNPPCA-HS / Nursing Association shall get the approval of the draft copy of the public notice from the Committee before causing the public notice in the News Papers. The Association shall notify about the availability of the application forms in the places mentioned above, in two leading newspapers, one in English and one in Tamil, having wide circulation and start issuing application forms from the date of such publication.

- e) The last date of receipt of the filled in application forms shall be specifically stated in the notification as well as in the instruction booklet.
- f) The TNPPCA-HS / Nursing Association shall notify in the instruction booklet that the student have to submit the copy of the filled application forms to the Office of the Committee.
- g) The TNPPCA-HS / Nursing Association shall furnish the name of the organization which it engaged or to be engaged for scanning the coding sheets submitted by the candidates along with the application forms.
- 4. On receipt of the filled in application forms within the time prescribed, the Associations have to submit the list of students applied for Allied Health Science courses within 48 hours from the last date of receiving applications to the Committee. The TNPPCA-HS / Nursing Association shall prepare the rank list and send it to the Committee for approval, before its publication. The TNPPCA-HS / Nursing Association shall also, along with the rank list, furnish necessary details such as names of the candidates, register number and the subjectwar marks obtained in the qualifying examination-community of the candidate, the status of the institution whether minority or not, along with the nature of minority, to the Committee in quadruplicate.
- 5. On approval of the rank list by the Committee, the TNPPCA-HS / Nursing Association shall publish the rank list in its registered office and in the premises of the member colleges. The merit list of the selected candidates shall be submitted to the Committee's office on or before 15.09.2025. The TNPPCA-HS / Nursing Association shall host the rank list in its official website.
- 6. Admissions of students for B.Sc.(Nursing) course should be made by each of the Two agencies from out of their own rank list. Part filling up of seat from the rank list of TNPPCA-HS Association / Nursing Association is not permitted as the standard of the merit list are different.

- 7. The admission shall begin immediately after publication of the rank list, Nursing courses admission shall be completed on or before 30.09.2025 and Pharmacy Course admission shall be completed on or before 30.10.2025. On completion of admission, the list of students with rank should be furnished to the Committee on or before 03.10.2025 for Nursing Courses and on or before 03.11.2025 for Pharmacy Course.
- 8. Admission of NRI students shall be made in accordance with the Government Orders in. G.O.Ms.No. 346, Health and Family Welfare (MCA-1) Department, dated. 19.10.2009. The lapsed / unfilled seats under NRI Quota shall be filled in on the basis of the rank list of the TNPPCA-HS / Nursing Association.
- 9. The minority institution shall admit students of its own community on the basis of inter-se rank among the students. If the seats cannot be filled up from among the students of the community / language, then the unfilled seats shall be filled up by admitting students of other communities, on the basis of rank list of the TNPPCA-HS/Nursing Association or the Government on getting approval from the Committee.
- 10. The list of students admitted, their rank number, the category under which admissions are made fees collected from them and other related particulars and details shall be forwarded to the Committee, "i.e. as and when the acts mentioned there in take place".
- 11. The Committee hereby directs the TNPPCA-HS / Nursing Association, to see that, no Institution under it could collect capitation fee in any form from the students, since it is strictly prohibited as per the Supreme Court Judgments. Necessary statement shall be incorporated in the prospectus also.
- 12. The State Government, in its turn, through the Director of Medical Education, shall furnish list of students admitted, in respect of the seats given to the State Government by the member-institutions of the Association, so as to enable the Committee to correlate /reconcile the

number of seats given to them and admissions made therefor. The list to be furnished as above shall contain all the details required to be furnished by the TNPPCA-HS / Nursing Association.

13.The Office bearers of the TNPPCA-HS and Nursing Association shall be responsible for their respective admission processes. They are permitted to nominate a responsible person for the above purpose, with the approval of the Committee. The Committee, in its turn, will nominate a person to oversee the admission process.

The Committee reserves its right to give further directions either to the TNPPCA-HS/ Nursing Association in general or to the institutions in particular, which shall be complied with by them and call for any further particulars, if required.

The conditions imposed above are in consonance with the Supreme Court judgments on this issue. If any admission is found to be made, contra, by any institution(s), it is made clear that the institution(s) shall be dealt with appropriately, which includes proposal for levy of penalty and also for derecognition or de-affiliation, as cautioned by the Supreme Court.
